Scenes or plots containing violence, and portraying the process of rape, the portrayal of which may lead people to think it is acceptable to carry out sexual assault on others. 	<ol style="list-style-type: none"> 1. Detailed portrayal of the process of rape. 2. Dialogue, audio or action of strong sexual implication. 3.
