Note:

1. When employers hire foreign workers to engage in industry category intermediate skilled work they must meet the provisions of a “professional license,” “training classes” or “practical work certification.
2. When employers hire foreign workers to engage in industry category intermediate skilled work, the average regular salary per worker per month must be a minimum of NT\$33,000 or total annual salary per worker cannot be lower than NT\$500,000. However, the first time a foreign student, overseas Chinese student or student of other Chinese descent, who graduated from a college or university in Taiwan and obtained an associate degree or higher, is employed to engage in industry category intermediate skilled work they must be paid an average regular salary of no less than NT\$30,000 per worker per month.
3. When employers hire foreign workers to engage in industry category intermediate skilled work and provide a regular monthly salary of NT\$35,000 or more, the requirement for “professional license,” “practical work certification” or “training classes” is waived.
4. Regular monthly salary as defined by the Directorate General of Budget, Accounting and Statistics, Executive Yuan, refers to the work remuneration paid to employees on a monthly basis, including basic monthly pay as well as fixed allowances and bonuses paid each month: rent allowance, travel expenses, boarding costs, utility (electricity/water) costs, monthly work bonus (production, performance, sales) and perfect attendance bonus; If payment is made in-kind, it should be discounted at current value; The above figures do not include the deduction of income tax, insurance payments and union membership dues.

(2)	Live-in Care Work	Required to have certified documentation attesting an individual undertook 20 hours or more of hands-on supplementary training (designated training locations / approved home based training locations) or online digital courses from the supplementary training section of the Ministry of Labor’s Transnational Labor Rights Protection Portal and obtained a supplementary training completion certificate.	

Note:

1. When employers hire foreign workers to engage in social welfare category intermediate skilled work they must have a “Mandarin Chinese (Hoklo) language proficiency” and “Continuing education program / supplementary training program” qualification.
2. When employers hire foreign workers to engage in intermediate skilled institutional care work, the average regular salary per worker per month must be a minimum of NT\$29,000.
3. When employers hire foreign workers to engage in intermediate skilled live-in care work, the average total salary per worker per month

must be a minimum of NT\$24,000.

4. When employers hire foreign workers to engage in intermediate skilled institutional care work and provide a regular monthly salary of NT\$31,000 or more, or hire foreign workers to engage in intermediate skilled live-in care work and provide a total monthly salary of NT\$26,000 or more, the requirement for “Mandarin Chinese (Hoklo) language proficiency” and “Continuing education program / supplementary training program” qualifications is waived.
5. Regular monthly salary as defined by the Directorate General of Budget, Accounting and Statistics, Executive Yuan, refers to the work remuneration paid to employees on a monthly basis, including basic monthly pay as well as fixed allowances and bonuses paid each month: rent allowance, travel expenses, boarding costs, utility (electricity/water) costs, monthly work bonus (production, performance, sales) and perfect attendance bonus; If payment is made in-kind, it should be discounted at current value; The above figures do not include the deduction of income tax, insurance payments and union membership dues. Total monthly salary as defined by the Directorate General of Budget, Accounting and Statistics, Executive Yuan, refers to the actual salary paid to an employee at the end of the month, including regular salary, overtime pay and other irregular earnings.
