Notes to Applicant	<ol style="list-style-type: none"> 1. The operation plan shall provide information about the location, area of the station as well as anticipated deployment diagrams for basic facilities and machinery & equipment, application of the capital and estimated operational expenditure/revenue. 2. Capital: The container terminal operator shall fill in the field with the paid-in capital, while the container terminal operator and foreign vessel carriers shall fill in the field with the amount of their operational funds in the ROC territories. 3. Documents written in a foreign language shall be processed in accordance to the requirements stated in Article 5 of the “Regulations for Administrating Container Terminal Operators”. 4. Three copies shall be enclosed for each application form and attachment, and required company seals shall be affixed to the blank space of each document. 5. An applicant who applies for operation of port Container Terminal Operators shall additionally submit the photocopy of the investment, construction or leasing agreement with the port operation company. 6. The foreign vessel carrier company who applies for operation of port container terminal operator as a second business shall additionally submit the photocopy of the investment, construction or leasing agreement with the port operation company.
