### **I. Necessary Items for the Application of the Certificate of Vessel's Nationality**

#### **(I) Required documents :**

1. The applicant shall submit a hard copy of establishment registration card or change of registration certificate issued by the competent authority if he or she is a juridical person.
2. The applicant shall submit the former original Certificate of Vessel's Nationality if he or she applies for a renewal or a change.
3. The issued Provisional Certificate of Vessel's Nationality should be returned before registering an ownership registration.
4. An agent should bring an agent's identity certification documents when he or she makes an application ; meanwhile, the agent should bring a power of attorney with a seal and identity certification documents of the ship owner.
5. The applicant or agent is required to bring two kinds of identification documents (e.g. identity card, health insurance card, or other effective documents) for inspection.

#### **(II) Notices:**

1. An application for the issue, renewal, duplicate, or change of the Certificate of Vessel's Nationality should be submitted by the ship owner.
2. An application for renewal should be submitted when name of the ship owner, port of registry , or the use of vessel is changed.

### **II. Application for Provisional Certificate of Vessel's Nationality**

#### **(I) Required documents :**

1. The applicant shall submit a hard copy of establishment registration card or change of registration certificate issued by the competent authority if he or she is a juridical person.
2. Before preservation of the proprietorship, the applicant shall submit the official documents for import approved by the competent authority, the sale or shipbuilding contract, the original tonnage certificate (a new ship is exempt from the certificate), and the practical measurement certificate with the application form.
3. An employee certificate should be attached as part of application which is submitted by the captain. The agent should bring a power of attorney with a seal and identity certification documents of the ship owner when he or she makes an application; meanwhile, the agent should bring his or her identity certification documents.
4. The applicant, captain, or agent is required to bring two kinds of identification documents (e.g. identity card, health insurance card, or other effective documents) for inspection.

#### **(II) Notices:**

1. An application for issue of the Provisional Certificate of Vessel's Nationality should be submitted by the ship owner. An application for renewal, duplicate, or change of Provisional Certificate of Vessel's Nationality should be submitted by the ship owner or captain.
2. A ship acquired abroad which has been measured by the same mode as that of the R.O.C. may be exempted from re-measurement. (the certification for the waiver of measurements shall be obtain from a ship register institute commissioned by the competent authority).  
A ship acquired abroad which has been measured by a different mode from that of the R.O.C. shall be re-measured through an application made in accordance with the relevant regulations.
3. A ship owner who acquires a ship at a port other than the recognized port of registry may apply for a Provisional Certificate of Vessel's Nationality (Register) to the shipping administration authority at the port of calling or the port of registry, by submitting the relevant supporting documents of ship acquisition or original ship nationality. An application of the Certificate of Vessel's Nationality within 3 months from the date of obtaining a Provisional Certificate of Vessel's Nationality (Register).
4. The validity of the Provisional Certificate of Vessel's Nationality (Register) shall not exceed six months for a ship navigating abroad, or three months for a ship navigating within domestic waters. However, for cases with proper reasons, application may be made for renewal to the shipping administration authority at the port of calling or port of registry before the expiry of the certificate, stating the reason. Validity of the renewed certificate shall not exceed one month, and only one renewal is allowed.

### **III. Fees:**

- (I) The fees is NT\$500 for each issue, replacement, or reissue of the Certificate of Vessel's Nationality.
- (II) The fees is NT\$250 for each change.
