

Addendum 1 : Other documents stipulated by the Central Competent Authority in Subparagraph 4, Paragraph 1, Article 13

1. Ocean fishing work:

- (1) Original copy of review fee receipt.
- (2) Original copy of the recruitment permit letter or replacement recruitment permit letter and list of foreign workers (individuals who provide a re-recruitment permit letter are also required to submit the original copy of the recruitment visa entry permit letter and list of foreign workers, whereas those without a recruitment permit letter for continued employment are not required to do so).
- (3) **Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.**
- (4) Those without a recruitment permit letter for continued employment are required to submit the following documents:
 - 1) A caged aquaculture businesses zone designated fishing industry license issued by the authority in charge of the target business or competent authority, a caged aquaculture businesses entry certificate issued by an exclusive fishing rights holder or a fishing license.
 - 2) Original copy of domestic crew list (not required for cage-aquaculture ocean fishing workers).

2. Live-in home help work:

- (1) Original copy of review fee receipt.
- (2) Original copy of a certified health check compliance document issued by a hospital approved by the Central Competent Health and Welfare Authority to conduct health examinations of foreign workers in the country of origin, or a certified document attesting that the foreign worker passed his/her training at a training unit designated by the labor department in the country of origin before entering the Republic of China (if foreign workers in other work categories transfer to become a live-in caregiver or home help, this requirement does not apply to those individuals who have worked in either position in the Republic of China for six months or more).
- (3) Original copy of the recruitment permit letter or recruitment replacement permit letter and list of foreign workers (individuals who provide a re-recruitment permit letter are also required to submit the original copy of the recruitment visa entry permit letter and list of foreign workers, whereas those without a recruitment permit letter for continued employment are not required to do so).
- (4) **Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.**
- (5) Those without a recruitment permit letter for continued employment are required to submit the following documents:
 - 1) Photocopies of the household registration certificate for the applicant and care recipient, certified documents attesting to the degree of kinship between the applicant and the care recipient, or an Alien Resident Certificate.
 - 2) Photocopy of the applicant's employment permit letter issued by the Central Competent Authority (to be provided by applicants who are working or investing in the Republic of China).
 - 3) Certified documents for foreign nationals investing in the Republic of China (to be

provided by applicants who use foreign capital to invest in Taiwan, where total capital meets the required standard, affixed with the official seal of the company and person in charge).

- 4) Photocopy of the previous year's profit-making enterprise income tax settlement declaration for the company where the applicant works (to be provided by applicants from companies where turnover meets the required standard).
 - 5) Photocopy of the applicant's income tax payment receipt for the previous year or employment contract (to be provided by applicants whose annual salary or monthly salary meets the required standard, affixed with the official seal of the company and responsible person).
 - 6) An organizational chart and certificate of employment issued by the company for whom the applicant works (affixed with the official seal of the company and the responsible person).
 - 7) Evidence that individuals confirmed by the central competent authority for the target business served as a senior official or core technical member of a research and development team in an overseas startup company that was taken over by another company for US\$5 million or more (to be provided by individuals who served as a senior official or core technical member of a research and development team in an overseas startup company that was taken over by another company for US\$5 million or more).
 - 8) Evidence that individuals confirmed by the central competent authority for the target business served as a senior official or core technical member of a research and development team in an overseas startup company that was successfully listed on the stock market (to be provided by individuals who served as a senior official or core technical member of a research and development team in an overseas startup company that successfully listed on the stock market).
 - 9) Evidence that individuals confirmed by the central competent authority for the target business served as a senior official at a venture capital company or fund that invested US\$5 million or more in overseas startups or businesses (to be provided by individuals who served as a senior official at a venture capital company or fund that invested US\$5 million or more in overseas startups or businesses).
 - 10) Evidence that individuals confirmed by the central competent authority for the target business served as a senior official at a venture capital company or fund that invested US\$1 million or more in domestic startups or businesses (to be provided by individuals who served as a senior official at a venture capital company or fund that invested US\$1 million or more in domestic startups or businesses).
- (6) Proof of completion of pre-employment training (to be provided unless the Central Competent Authority can access the documents online).
- (7) Certified documents attesting to the kinship relationship between the person who attended a class on behalf of the employer and the care recipient (to be provided by individuals entrusted by the employer to participate in an online class who meet the degree of kinship requirement).
- (8) A certificate of cohabitation for the person who attended a class on behalf of the employer and the care recipient, or a certified document or affidavit attesting that an individual has been given management and supervisory authority by the employer.

3. Manufacturing work

- (1) Original copy of review fee receipt.
- (2) Original copies of the recruitment visa entry permit letter and list of foreign workers or a replacement recruitment permit letter and list of foreign workers (not required for

those without a recruitment permit letter for continued employment).

(3)Original copy of certified documents attesting to a specific production process issued by the central competent business authority for the target industry or free trade port zone management agency (to be provided by employers who meet the requirements of the Central Competent Authority for the continued employment of foreign workers pursuant to the provisions of Subparagraph 2 or 4, Paragraph 1, Article 7).

(4) Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.

4. Construction work:

(1)Original copy of review fee receipt.

(2)Original copies of the recruitment visa entry permit letter and list of foreign workers or a replacement recruitment permit letter and list of foreign workers (those with a re-recruitment permit letter should also submit the original copy of the visa entry permit letter and list of foreign workers, which is not required for those without a recruitment permit letter for continued employment).

(3)Public construction projects are required to submit a “Public Construction Project, Project Value and Construction Period Certificate.”

(4)Major private construction projects are required to submit a “Major Private Construction Project, Project Value and Construction Period Certificate.”

(5)Photocopy of standard construction contracts (to be provided by standard construction contractors)

(6)The central competent authority for the target industry is required to confirm that certified documentation meets the provisions of Addendum 9-1, Article 47-1 of the Review Standards (to be submitted by those who fall under Article 47-1 of the Review Standards)

(7) Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.

5. Institutional care work:

(1)Original copy of review fee receipt.

(2)Original copy of a certified health check up compliance document issued by a hospital approved by the Central Competent Health and Welfare Authority to conduct health examinations of foreign workers in the country of origin or a certified document attesting that the foreign worker passed his/her training at a training unit designated by the labor department in the country of origin before entering the Republic of China, as well as original copies of the accredited certified documents in two languages (to be provided by foreign workers in other work categories who want to transfer to live-in care giving or home help work, while foreign nationals who previously worked in the Republic of China as a care giver or home help for six months or more are exempt from this provision).

(3)Original copy of the recruitment permit letter or recruitment replacement permit letter and list of foreign workers (individuals who provide a re-recruitment permit letter are also required to submit the original copy of a visa entry permit letter and list of foreign workers, whereas those without a recruitment permit letter are not required to do so).

(4) Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.

(5)Applicants who do not have a recruitment permit letter for continued employment are required to provide the following documents:

1) Photocopy of a Tax ID Number assignment notification.

- 2) Photocopy of certified documents attesting to the number of beds issued by the competent authority for the target industry
- 3) Original copy of a list of domestic care workers or nurses verified by the competent authority for the target industry (to be provided if the applicant is a long-term care facility, care institution, nursing home institution, or social welfare foundation, nursing institution or long-term care services institution).
- 4) Original list of domestic caregivers and copies of their attendant training completion certificate, care attendant profession technician certificate, valid long-term care attendant certificate or graduation certificates from a senior high school (vocational college) or higher -- junior college, university, division or graduate school in the field of care work and nursing (to be provided if the applicant is a hospital).

6. Live-in care work:

- (1) Original copy of review fee receipt.
- (2) Original copy of a certified health check up compliance document issued by a hospital approved by the Central Competent Health and Welfare Authority to conduct health examinations of foreign workers in the country of origin or a certified document attesting that the foreign worker passed his/her training at a training unit designated by the labor department in the country of origin before entering the Republic of China, as well as original copies of the accredited certified documents in two languages (to be provided by foreign workers in other work categories transferring to care giving or live-in home help work, while individuals who previously worked in the Republic of China as a care giver or home help for six months or more are exempt from this provision).
- (3) Original copy of the recruitment permit letter or recruitment replacement permit letter and list of foreign workers (those who provide a re-recruitment permit letter are also required to submit the original copy of a visa entry permit letter and list of foreign workers, whereas those without a recruitment permit letter are not required to do so).
- (4) Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.
- (5) Applicants who do not have a recruitment permit letter for continued employment are required to provide the following documents:
 - 1) Photocopies of the Household Registration Certificate for the applicant and care recipient, as well as certified documents attesting to the kinship relationship between the applicant and care recipient, or a copy of an Alien Resident Certificate.
 - 2) Photocopy of a Disability Certificate (to be provided by applicants who file an application based on a specific physical or mental disability or a disability classification and assessment announced by the competent health authority); However, applicants who apply for foreign live-in caregivers on the grounds of a physical handicap (limited to category two illnesses such as motor neuron disease or Parkinson's disease) or rare diseases (limited to motor neuron disease), who have not previously hired a foreign live-in caregiver or intermediate skilled live-in foreign caregiver, are required to provide a photocopy of the certificate of diagnosis or a physical and mental disability assessment identifying either motor neuron disease, amyotrophic lateral sclerosis (ALS), or Parkinson's disease.
 - 3) Original copy of an affidavit attesting that the care recipient has no family in the Republic of China (to be provided by applicants when the employer and care recipient have no kinship relationship).
 - 4) Original copy of a foreign worker employment and management letter of authorization and a photocopy of the identity documents of the commissioned party. However,

when the commissioned party is an institution, group, or other business entity, certified documents must be submitted from the competent authority for the target industry agreeing to accreditation or legal entity registration (to be provided when the care recipient is also the applicant employer).

5) Original copy of an affidavit giving up the replacement recruitment quota (to be provided when, pursuant to Article 58 of the Act, a foreign worker has his/her employment terminated while the employment permit remains valid, for reasons not attributable to the employer, and said employer remains eligible to apply for a replacement recruitment).

6) Original copy of an affidavit giving up the replacement recruitment quota (to be provided when, pursuant to Article 58 of the Act, a foreign worker has his/her employment terminated while the employment permit remains valid, for reasons not attributable to the employer, and said employer remains eligible to apply for replacement recruitment).

(6) Certified documents attesting to the completion of pre-employment training (to be provided unless the Central Competent Authority can access the documents online).

(7) Certified documents attesting to the kinship relationship between the person who attended a class on behalf of the employer and the care recipient (to be provided by individuals entrusted by the employer to take an online class who meet the degree of kinship requirement).

(8) A certificate of cohabitation for the person who attended a class on behalf of the employer and the care recipient, or a certificate or affidavit attesting that an individual has been given management and supervisory authority by the employer.

7. Slaughterhouse work:

(1) Original copy of review fee receipt.

(2) Original copy of an entry visa permit letter and list of foreign workers or original copy of a replacement recruitment permit letter and list of foreign workers (not required for employers without a recruitment permit letter for continued employment).

(3) Original copy of a certified document issued by the central competent authority for the target industry accrediting slaughterhouse work (to be provided by applicants who are eligible to engage in the continued employment of foreign workers prescribed by the Central Competent Authority, pursuant to the provisions of Subparagraph 2 or 4, Paragraph 1, Article 7)

(4) Photocopy of a slaughterhouse registration certificate issued by the central competent authority for the target industry (not required for employers with a recruitment permit letter for continued employment).

(5) Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.

8. Agriculture, forestry, animal husbandry or aquaculture work:

(1) Original copy of review fee receipt.

(2) Original copy of an entry visa permit letter and list of foreign workers or recruitment letter, original copy of a replacement recruitment permit letter and list of foreign workers (not required for employers without a recruitment permit letter for continued employment).

(3) Original copy of certified document issued by the central competent authority for the target industry accrediting agriculture, forestry, animal husbandry or aquaculture employer qualifications (to be submitted by applicants who are eligible to engage in the continued employment of foreign workers prescribed by the Central Competent

Authority, pursuant to the provisions of Subparagraph 2 or 4, Paragraph 1, Article 7).

(4) Certified documents on the number of domestic workers accredited by the central competent authority for the target industry.

(5) Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.

9. Outreach agricultural work:

(1) Original copy of review fee receipt.

(2) Original copy of an entry visa permit letter and list of foreign workers or replacement recruitment permit letter and list of foreign workers (not required for employers without a recruitment permit letter for continued employment).

(3) Photocopies of certified documents issued by the central competent authority for the target industry approving an outreach agricultural services plan and qualifications (to be provided by applicants who are eligible to engage in the continued employment of foreign workers prescribed by the Central Competent Authority, pursuant to the provisions of Subparagraph 2 or 4, Paragraph 1, Article 7).

(4) Photocopies of certificates of incorporation for any cooperative or non-profit-seeking organization related to farmers' associations, fishermen's associations, agriculture, forestry, fishery and animal husbandry (not required for employers with a recruitment permit letter for continued employment).

(5) Certified documents provided by foreign nationals when applying to the immigration authorities for residence in Taiwan.

10. Bilingual translation work:

(1) Original copy of review fee receipt.

(2) Photocopy of the employed foreign worker's graduation certificate from local or overseas senior high school level or above, or an equivalent academic certification (this does not apply to foreign nationals originally involved in bilingual translation work).

(3) Original copy of a list of employees at the private employment service agency (this does not apply to applicants already commissioned to manage foreign workers).

(4) Photocopy of a letter of authorization attesting to an individual being commissioned to manage foreign workers (this should clearly stipulate the number and nationality of the foreign workers to be managed and does not apply to applicants employed at private employment service agencies).

11. Chefs and related work:

(1) Original copy of review fee receipt.

(2) Photocopies of the employed foreign worker's graduation certificate from local or overseas senior high school level or above, or equivalent academic certification (this does not apply to foreign nationals originally involved in chef and related work).

(3) Work experience certificate issued by a hotel or restaurant in the Republic of China or overseas, attesting to a minimum of not less than one year of chef or related work experience (this does not apply to foreign nationals originally involved in chef and related work).

(4) Photocopy of a letter of authorization attesting to an individual being commissioned to manage foreign workers (this should clearly stipulate the number and nationality of the foreign workers to be managed).

12. Intermediate skilled work:

(1)Original copy of review fee receipt.

(2)Intermediate skilled ocean fishing work:

- 1.A caged aquaculture businesses zone designated fishing industry license issued by the authority in charge of the target business or competent authority, a caged aquaculture businesses entry certificate issued by an exclusive fishing rights holder or a fishing license.
- 2.Original copy of domestic crew list (not required for cage-aquaculture ocean fishing workers).
- 3.Certified documents for foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher (to be provided by foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher).
- 4.Certified documents attesting that a foreign worker has technical qualifications that meet the standard of a professional license, training class or practical accreditation (if an applicant's salary is in accordance with the level announced by the Central Competent Authority the professional license, training class or practical accreditation provisions do not apply).

(3) Intermediate skilled manufacturing work:

- 1.Original copy of certified documents attesting to a specific production process issued by the central competent business authority for the target industry or free trade port zone management agency (to be provided by employers who meet the requirements of the Central Competent Authority for the continued employment of foreign workers, pursuant to the provisions of Subparagraph 2 or 4, Paragraph 1, Article 7).
- 2.Certified documents for foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher (to be provided by foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher).
- 3.Certified documents attesting that a foreign worker has technical qualifications that meet the standard of a professional license, training class or practical accreditation (if an applicant's salary is in accordance with the level announced by the Central Competent Authority the professional license, training class or practical accreditation provisions do not apply).

(4) Intermediate skilled construction work:

- 1.Public construction projects are required to submit a "Public Construction Project, Project Value and Construction Period Certificate."
- 2.Major private construction projects are required to submit a "Major Private Construction Project, Project Value and Construction Period Certificate."
- 3.Certified documents for foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher (to be provided by foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher).
- 4.Certified documents attesting that a foreign worker has technical qualifications that

meet the standard of a professional license, training class or practical accreditation (if an applicant's salary is in accordance with the level announced by the Central Competent Authority the professional license, training class or practical accreditation provisions do not apply).

5. An affidavit designating one firm the employer in the case of projects involving co-contractors or as meeting the provisions of Paragraph 3, Article 42 of the Review Standards (to be provided when a public construction project or major private construction project has two or more co-contractors).
6. Photocopy of standard construction contract (to be provided by standard construction contractors).
7. Certified documents indicating the central competent authority for the target industry verifying compliance with the provisions of Addendum 9-1, Article 47-1 of the Review Standards (to be provided by those that fall under Article 47-1 of the Review Standards)

(5) Intermediate skilled institutional care work:

1. Photocopy of Tax ID Number assignment notification.
2. Photocopy of certified documents attesting to the number of beds issued by the competent authority for the target industry
3. Original copy of a list of domestic care workers or nurses verified by the competent authority for the target industry (to be provided if the applicant is a long-term care facility, care institution, nursing home institution, or social welfare foundation, nursing institution or long-term care services institution).
4. Original list of domestic caregivers and copy of their attendant training completion certificate, care attendant profession technician certificate, valid long-term care attendant certificate or graduation certificates from a senior high school (vocational college) or higher -- junior college, university, division or graduate school in the field of care work and nursing (to be provided if the applicant is a hospital).
5. Foreign workers are required to have one of the following certified qualifications attesting to their Mandarin Chinese (Hoklo) language ability (if an applicant's salary is in accordance with the level announced by the Central Competent Authority the Mandarin Chinese (Hoklo) language ability accreditation qualifications do not apply):
 - (1) Certified documents attesting a foreign worker attained "basic level" or higher in conversational or listening comprehension Mandarin Chinese as part of the Ministry of Education's Mandarin Chinese proficiency test or is certified "basic level" or higher (spoken and listening comprehension sections) in Hoklo language proficiency.
 - (2) Certified as having attended, for a minimum of 36 hours, a Mandarin Chinese language training program commissioned by a special municipality, county (city) government or an education institution permitted by the Ministry of Education to enroll students from overseas to learn Chinese in Taiwan.
 - (3) Where an employer has hired a foreign worker to engage in institutional care work for three years or more and self accredits the care worker as having attained a level of competence in Mandarin Chinese that meets the qualification standard announced by the Central Competent Authority, having obtained an employer self-assessment foreign worker language proficiency form.
6. Where a foreign worker has one of the following certified documents but their salary meets the level announced by the Central Competent Authority, the following documents do not have to be attached:
 - (1) Certified document attesting an individual received 20 hours or more of continued education or 20 points in the year prior to the application.

- (2) A certificate indicating an individual obtained an associate degree or higher from a long-term care related department or completed a long-term care program announced by the Central Competent Authority.
 - (3) A care attendant technician's certificate.
7. Certified documents for foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher (to be provided by foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher).
- (6) Intermediate skilled live-in care work:
 1. Photocopies of the Household Registration Certificate for the applicant and care recipient, as well as certified documents attesting to the kinship relationship between the applicant and care recipient, or a copy of an Alien Resident Certificate.
 2. Photocopy of a Disability Certificate (to be provided by applicants who file an applications based on a specific physical or mental disability or the disability classifications and assessments announced by the competent health authority);
 3. Original copy of an affidavit attesting that the care recipient has no family in the Republic of China (to be provided by applicants when the employer and care recipient have no kinship relationship).
 4. Original copy of a foreign worker employment and management letter of authorization and a photocopy of the identity documents of the commissioned party. However, when the commissioned party is an institution, group, or other business entity, certified documents must be submitted from the competent authority for the target industry agreeing to accreditation or legal entity registration (to be provided when the care recipient is also the applying employer).
 5. Original copy of an affidavit giving up the replacement recruitment quota (to be provided when, pursuant to Article 58 of the Act, a foreign worker has his/her employment terminated while the employment permits remain valid, for reasons not attributable to the employer, and the employer remains eligible to apply for a replacement recruitment permit).
 6. Affidavit for change of applicant (to be provided when the name of the applicant to employ a foreign caregiver on the basic information form is different to that on the application).
 7. Certified documents attesting to the completion of pre-employment training (to be provided unless the Central Competent Authority can access the documents online).
 8. Certified documents attesting to the kinship relationship between the person who attended a class on behalf of the employer and the care recipient (to be provided by individuals entrusted by the employer to take an online class who meet the degree of kinship requirement).
 9. A certificate of cohabitation for the person who attended a class on behalf of the employer and the care recipient, or a certificate or affidavit attesting that an individual has been given management and supervisory authority by the employer.
 10. Foreign workers are required to have one of the following certified qualifications attesting to their Mandarin Chinese (Hoklo) language ability (if an applicant's salary is in accordance with the level announced by the Central Competent Authority the Mandarin Chinese (Hoklo) language ability accreditation qualifications do not apply):
 - (1) Certified documents attesting a foreign worker attained "basic level" or higher in conversational or listening comprehension Mandarin Chinese as part of the Ministry of

- Education's Mandarin Chinese proficiency test or is certified "basic level" or higher (spoken and listening comprehension sections) in Hoklo language proficiency.
- (2) Certified as having attended, for a minimum of 36 hours, a Mandarin Chinese language training program commissioned by a special municipality, county (city) government or an education institution permitted by the Ministry of Education to enroll students from overseas to learn Chinese in Taiwan.
 - (3) Where an employer has hired a foreign worker to engage in institutional care work for three years or more and self accredits the care worker as having attained a level of competence in Mandarin Chinese that meets the qualification standard announced by the Central Competent Authority, having obtained an employer self-assessment foreign worker language proficiency form.
11. Certified documents attesting a foreign worker undertook 20 hours or more of hands-on supplementary training (at designated training locations / approved home based training locations) or online digital courses from the supplementary training section of the Ministry of Labor's Transnational Labor Rights Protection Portal. However, if an applicant's salary is in accordance with the level announced by the Central Competent Authority, the hands-on supplementary training requirement does not apply.
 12. Certified documents for foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher (to be provided by foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher).
- (7) Intermediate skilled outreach agricultural work:
1. Photocopies of certified documents issued by the central competent authority for the target industry approving an outreach agricultural services plan and employer qualifications (to be provided by applicants who are eligible to engage in the continued employment of foreign workers prescribed by the Central Competent Authority, pursuant to the provisions of Subparagraph 2 or 4, Paragraph 1, Article 7).
 2. Photocopies of certificates of incorporation for any cooperative or non-profit-seeking organization related to farmers' associations, fishermen's associations, agriculture, forestry, fishery and animal husbandry.
 3. Certified documents for foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher (to be provided by foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher).
 4. Certified documents attesting that a foreign worker has technical qualifications that meet the standard of a professional license, training class or practical accreditation (if an applicant's salary is in accordance with the level announced by the Central Competent Authority the professional license, training class or practical accreditation provisions do not apply).
- (8) Intermediate skilled agricultural work:
1. Certified documents on agriculture, forestry, animal husbandry or aquaculture/fishing work accredited by the central competent authority for the target industry, pursuant to the provisions of Addendum 12, Article 56 of the Review Standards.

2. Plant seedlings industry registration certificate accredited by the central competent authority for the target industry.
3. Certified documents on number of domestic workers accredited by the central competent authority for the target industry.
4. Certified documents for foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher (to be provided by foreign overseas students, overseas Chinese students or other students of Chinese descent who graduated from a college or university in the Republic of China and obtained an associate degree or higher).
5. Certified documents attesting that a foreign worker has technical qualifications that meet the standard of a professional license, training class or practical accreditation (if an applicant's salary is in accordance with the level announced by the Central Competent Authority the professional license, training class or practical accreditation provisions do not apply).
