1. The relevant penalties stipulated in from Article 47 to Article 61 of this Act shall be categorized according to their patterns, and the weighting of the degree of violation shall be set at one to ten respectively.
2. The number of points to be weighted according to the degree of responsibility, severity, type and quantity of substances discharged for those who violates the obligations under this Act and causes marine pollution.
