

DECISION N° 12
MODIFICATION PURSUANT TO THE TARIFF TREATMENT FOR JELLY
READY FOR CONSUMPTION, ALOE VERA JUICE AND TAPE PRODUCTS
OF ANNEX 3.04 OF THE FREE TRADE AGREEMENT BETWEEN
THE REPUBLIC OF CHINA (TAIWAN), THE REPUBLIC OF EL SALVADOR
AND THE REPUBLIC OF HONDURAS

Signed on August 30, 2017
Entered into force on February 3, 2018

The Administrative Commission of the Free Trade Agreement between the Republic of China (Taiwan), the Republic of El Salvador and the Republic of Honduras (“the Agreement”), pursuant to its powers and according to what is established in Article 14.01 (3)(b)(i) of the Agreement and Article 8 of the Rules and Procedures of the Administrative Commission,

DECIDES:

To modify Annex 3.04 (1) (g) “Tariff Reduction Schedule” regarding the tariff treatment applied by the Republic of El Salvador to the Republic of China (Taiwan) to jelly ready for consumption, aloe vera juice and tape products, establishing a tariff reduction schedule to gradually eliminate the customs tariffs applicable to these goods.

El Salvador will apply to the originating merchandises from the Republic of China (Taiwan) the following tariff reduction schedule:
