I Note from Mr. H. K. Yang, Ambassador of the Republic of China, to Mr. R.F. Botha, Minister of Foreign Affairs and Information of the Republic of South Africa

CAPE TOWN, May 19, 1983

Dear Mr. Minister:

With a view to establishing uniform principles and rules for the determination of the tonnage of ships which are engaged in international voyages and registered in the Republic of South Africa or in the Republic of China, the Republic of China hereby proposes that the Republic of South Africa and the Republic of China agree to accept International Tonnage Certificates to be issued by the authority of either Government in conformity with the provisions of the International Convention on Tonnage Measurement of Ships, 1969, and under the following conditions:

- 1 Every ship registered in the Republic of South Africa which calls at ports of the Republic of China shall have an International Tonnage Certificate in conformity with the provisions of the said Convention. Such Certificate shall be drawn up in the form specified in Annex II of the Convention and it shall be available for inspection when the ship calls at ports of the Republic of China in the same manner as when the ship calls at the ports of the Parties to the Convention.
- 2 Although the Republic of China is not a party to the said Convention, every ship registered in the Republic of China which calls at ports of the Republic of South Africa shall have a certificate drawn up in conformity with the provisions of the Convention. Such certificate shall be availab-



le for inspection when the ship calls at ports of the Republic of South Africa.

If this proposal meets with the approval of the Government of the Republic of South Africa, I suggest that this Note and your Note in reply shall constitute an Agreement between the Governments of the Republic of South Africa and of the Republic of China.

- II Note from Mr. R.F. Botha, Minister of Foreign Affairs and Information of the Republic of South Africa to Mr. H.K. Yang, Ambassador of the Republic of China

Your Excellency:

I acknowledge receipt of your letter of today's date which reads word for word as follows:

" With a view to establishing uniform principles and rules for the determination of the tonnage of ships which are engaged in international voyages and registered in the Republic of South Africa or in the Republic of China, the Republic of China hereby proposes that the Republic of South Africa and the Republic of China agree to accept International Tonnage Certificates to be issued by the authority of either Govern-

ment in conformity with the provisions of the International Convention on Tonnage Measurement of Ships, 1969, and under the following conditions:

- (1) Every ship registered in the Republic of South Africa which calls at ports of the Republic of China shall have an International Tonnage Certificate in conformity with the provisions of the said Convention. Such Certificate shall be drawn up in the form specified in Annex II of the Convention and it shall be available for inspection when the ship calls at ports of the Republic of China in the same manner as when the ship calls at the ports of the Parties to the Convention.
- (2) Although the Republic of China is not a party to the said Convention, every ship registered in the Republic of China which calls at ports of the Republic of South Africa shall have a certificate drawn up in conformity with the provisions of the Convention. Such certificate shall be available for inspection when the ship calls at ports of the Republic of South Africa.

If this proposal meets with the approval of the Government of the Republic of South Africa, I suggest that this Note and your Note in reply shall constitute an Agreement between the Governments of the Republic of South Africa and of the Republic of China.”

I wish to confirm that this proposal meets with the approval of the Government of the Republic of South Africa and that your Note and this reply constitute an agreement between our two Governments as of today's date.
