This agreement is entered into between the Industrial Development & Investment Center in Taipei, hereinafter referred to as the IDIC, and the Ministry of the Brussels-Capital Region, Administration of Economy and Employment, hereinafter referred to as MBCR.

PREAMBLE:

It is the desire of IDIC and MBCR to create favourable conditions for residents and companies of the private sector of Taiwan and of the Brussels-Capital Region to make investment in both places for greater economic cooperation.

Therefore, it is agreed between the IDIC, represented by its Director General, Mr. Ricky Y. S. Kao, and the MBCR, represented by its Administrateur Général adjoint f.f, Mr. Jean-Claude MOREAU, and in anticipation of resolutions to be passed by IDIC and MBCR to finally ratify this agreement that:

AGREEMENT:

- 1.IDIC and MBCR will each take necessary steps to exchange information on the investment environment and incentives for the potential investors of both sides. They will notify each other and potential investors about this information,
- 2.IDIC and MBCR will take necessary steps to improve business conditions and to offer facilities of favourable conditions themselves. They will promote and assist potential investors to utilize those facilities.
- 3.IDIC and MBCR will respectively encourage and assist its firms to set up production facilities, distribution centers, service facilities and technological cooperation in the country of the other party. They will assist the investors from the other side to file investment applications or other necessary details and to provide them with other services after the application

is approved.

- 4.IDIC and MBCR will promote the visits of investment missions between the two parties and take notice to extend cooperation and assistance to potential investors recommended by the other party.
- 5.IDIC and MBCR will form a working committee to meet on a regular basis. The committee should be comprised of personnel assigned by both parties to work alternately in Taiwan and in the Brussels-Capital Region for suitable periods to enhance the cooperative relationship and technological interchange.
- 6.Both parties are fully aware of the fact that any decision made by residents and companies of the private sector from both sides in favour of the said facilities mentioned above is exclusively the result of a private business initiative, and IDIC and MBCR do not take any legal responsibility in this regard.
