I Note from Mr. William P. Rogers, American Secretary of State  
to Mr. James C.H. Shen, Chinese Ambassador.

September 20,1972

Excellency:

I have the honor to refer to the agreement between our two Governments concerning exports of wool and man-made fiber textile products from the Republic of China to the United States effected by exchange of notes on December 30,1971, and in particular to that portion of Annex B of the agreement entitled "Categories of Man-made Fiber Textile Products" . Pursuant to recent conversations between representatives of our two Governments, I have the honor to propose that the description of Category 222 as contained in Annex B be amended to read as follows: "Trousers, slacks and shorts, knit, men's, boys', women's, girls' and infants . . . . . If the foregoing is acceptable to your Government, this note and Your Excellency's note of acceptance on behalf of the Government of the Republic of China shall constitute an amendment of the wool and man-made fiber textile agreement effected by exchange of notes on December 30,1971.

II Note from Mr. James C.H. Shen, Chinese Ambassador to Mr. William P. Rogers, American Secretary of State.

Excellency:

I have the honor to acknowledge receipt of your note of this date which reads as follows:

“Excellency:

“I have the honor to refer to the agreement between our two Governments concerning exports of wool and man-made fiber textile products from the Republic of China to the United States effected by exchange of notes on December 30,1971, and in particular to that portion of Annex B of the agreement entitled “Categories of Man-made Fiber Textile Products” .
