Dear Mr. Wu:

Following consultations between the American Institute in Taiwan and the Coordination Council for North American Affairs as called for in paragraph 5, as amended, of the Bilateral Textile Trade Agreement of June 8,1978, I wish to confirm the request of the American Institute in Taiwan that the Coordination Council for North American Affairs limit exports to the United States of products classified in Category 337 to a level of 120,000 dozen during 1980.

I also wish to confirm the request of the American Institute in Taiwan that the Coordination Council for North American Affairs limit exports to the United States of products classified in TS-USA No. 310.5049 to a level of 2,700,000 SYE during 1980, and that the following conditions apply: (a) CCNAA will not permit exports to the United States of this product during the period October 1-December 31,1980, and (b) the 1980 limit (for the purposes of sub-paragraphs 5(e)(ii) and 5(e)(iv) of the Agreement) -

and the 1980 level of trade (for the purpose of sub-paragraph 5(e) (v)) shall henceforth be considered to have been 1,700,000 SYE.

I would appreciate confirmation from you that the Coordination Council for North American Affairs agrees to the above requests.
