GENERAL AGREEMENT OF  
TECHNICAL COOPERATION

The Taiwan Power Company (TPC) a company of Taiwan, Republic of China with headquarters at 242, Roosevelt Road, Section 3, Taipei, Taiwan, Republic of China,  
and

Vattenfall AB, a state owned company with headquarters at S-162 87 Vallingby, Sweden,

Whereas similarities exist in Taiwan and Sweden with respect to the electricity production, transmission and distribution as well as to the role of TPC and Vattenfall,

Whereas, parties

- Convinced that the cooperation between their companies will lead to scientific, technical and economic advantages for both parties and wishing to increase their cooperation in the field of the electricity production, transmission and distribution ;
- Recalling their common commitment to the peaceful utilization of nuclear energy and important role it plays in their electricity production;

HAVE REACHED THE FOLLOWING

UNDERSTANDING:

ARTICLE 1- FIELDS OF  
COOPERATION

The TPC and Vattenfall will promote and develop the cooperation in the fields of electricity production, transmission and distribution include those areas listed on the ATTACHMENT of this. Agreement. Other areas of cooperation may be added and deleted by joint decision of both parties.

ARTICLE 2 - FORMS OF  
COOPERATION

The cooperation between TPC and Vattenfall could be realized by the following ways:

- Exchange of information, documentation
- Exchange of visitors
- Mutually arranged meetings, training programs, workshops and symposia
- Joint research and development programs
- Performance of technical services

TPC and the Vattenfall will endeavour to promote cooperation by giving favorable assistances to the exchange of experts, admittance of nationals from their countries for purpose of visits, meetings, or for the performance of joint programs.

#### ARTICLE 3 - PROGRAMS OF COOPERATION

- 3.1 Either party may make a request for cooperation task by a letter sent at least one (1) month in advance, with the exception of emergency cases.
- 3.2 Any cooperation task falling under the category of the scope of cooperation may be requested by either party, and may be supplied by the other party, provided neither party is obliged to disclose any act, matter and/or item which such party is prohibited from disclosing by law, custom or contract.
- 3.3 Once a year at least; the representatives appointed by TPC and Vattenfall will meet to review the progress achieved and prepare as far as possible a program of the activities for the following months. They will fix also the best ways to comply with the program.

#### ARTICLE 4 - COMPENSATION

- 4.1 As a general principle, it is agreed that the information and/or documentation exchanged in the framework of the cooperation shall be sent, translated into English, to the requesting party, free of charge to the extent that such information and/or documentation is readily available with the sending party, providing that the sending party shall have the

right to request reasonable compensation for the cost of producing such information and/or documentation in cases when it is not so available.

4.2 In case either party needs the advice or consultation of specialists within the scope of cooperation, the parties shall discuss and set up a separate agreement regarding the terms and conditions on a case-by-case basis. In such case, the benefiting party should be informed and his agreement be obtained before the other party starting the assignment.

#### ARTICLE 5 - CONFIDENTIALITY

The Parties agree to maintain the confidentiality of all information exchanged under this Agreement. All proprietary information received from each party shall not be disclosed to any third party without the prior written consent of the providing Party.

#### ARTICLE 6 - BODIES IN CHARGE OF THE COOPERATION

All notices and communications pursuant to this Agreement shall be in writing and shall be sent to the following addressees:

#### ARTICLE 8 - VALIDITY OF AGREEMENT

This Agreement will become effective on the date of signature by the parties hereto and is valid up to December 31, 1966. The per-

iod of duration can be extended, based upon the mutual agreement in writing.
