**PREAMBLE** 

THE FEDERATION OF THAI INDUSTRIES (FTI) AND THE CHINESE NATIONAL ASSOCIATION OF INDUSTRY AND COMMERCE (CNAIC) SHARE THE SAME OBJECTIVES OF PROVIDING THEIR MEMBERS WITH A WIDE RANGE OF SERVICE IN ECONOMIC, TECHNICAL. INDUSTRIAL, AND BUSINESS MATTERS, AND BOTH PARTIES HEREBY AGREE TO WORK IN COOPERATION TO PURSUE THE FOLLOWING:

- I TO PROMOTE BILATERAL TRADE, INVESTMENT, INDUSTRIAL, AND BUSINESS DEVELOPMENT, ECONOMIC AND TECHNICAL COOPERATION, INTERNATIONAL MARKET- ING, CULTURAL AND EDUCATIONAL INTERFLOUT, AND TOURISM.
- II TO ESTABLISH AND PROVIDE A CHANNEL OF COMMUNICATION BETWEEN BUSINESS COMMUNITIES OF THE TWO COUNTRIES.
- III TO EXCHANGE INFORMATION REGARDING THE PROMOTION OF BILATERAL ECONOMIC COOPERATION AND TRADE RELATIONS.
- IV TO PROMOTE AND ARRANGE EXCHANGES OF VISITS BY DELEGATIONS AND INDIVIDUAL BUSIMESSMEN OF THE TWO COUNTRIES AND TO RENDER NECESSARY ASSISTANCES AND COOPERATION BY THE ORGANIZATIONS IN THE HOST COUNTRIES.
- V TO FOSTER FRIENDSHIP AND UNDERSTANDING BETWEEN THE TWO BUSINE-SS ORGANIZATIONS AND TO ESTABLISH CLOSER COOPERATION IN ACTNI-TTES WHICH WILL ENHANCE MUTUAL GROWTH OF BUSIINESS.
- VI TO RECOMMEND TO RELEVANT AUTHORITIES ALL SUCH MEASURES AS WO-ULD BE BENEFICIAL, AND HELPFUL, TO INCREASE OF TRADE AND ECO-NOMIC COOPERATION BETWEEN THE TWO COUNTRIES.
- VII TO PROMOTE SUCH OTHER OBJECTIVES AND PURPOSES CONSISTENT WI-TH THE ABOVE MENTIONED PURPOSES AND OBJECTIVES FOR THE GENE-RAL WELFARE OF BOTH BUSINESS COMMUNITIES.

IN ACCORDANCE WITH THE FOREGOING, THE FTI AND CNAIC THEREFORE E-NTER INTO A COOPERATION AGREEMENT AS SET OUT IN THE FOLLOWING:



## **CLAUSES**

#### FIRST

BOTH PARTIES AGREE TO UNDERTAKE VARIOUS STUDIES TO DETERMINE THE TYPE OF ACTION AND SUPPORT WHICH MIGHT BENEFIT THEIR MEMBERS UNDER THIS AGREEMENT. THEY FURTHER AGREE THAT THEY WILL EMPHASIZE ON THE MANUFACTURING SECTORS IN THE BEGINNING.

### SECOND

TO PURSUE THE COMMON OBJECTIVES REPRESENTATIVES OF THE TWO PARALLE BUSINESS ORGANIZATIONS WILL MEET JOINTLY AT A TIME AND LOCATION TO BE DETERMINED BY THE TWO CHAIRMEN. THE VENUE ALTERNATING BETWEEN THE AFOREMENTIONED ORGANIZATIONS.

#### THIRD

MEETING OF THE JOINT BUSINESS ORGANIZATIONS WILL BE COCHAIRED BY THE CHAIRMEN OF BOTH ORGANIZATIONS OR IN THEIR ABSENCE SUCH OTHER PERSON AS NOMINATED BY EITHER OR BOTH ORGANIZATIONS TO ACT AS CHAIRMAN.

# **FOURTH**

BETWEEN MEETINGS OF THE JOINT BUSINESS ORGANIZATIONS THE TWO CHAIRMEN MAY MEET AS REQUIRED FOR THE EFFICIENT CONDUCT OF THE TWO ORGANIZATIONS.

THEY MAY MEET ALTERNATIVELY IN BANGKOK AND TAIPEI OR AT SUCH OTHER VENUE AS MAY PROVE MORE CONVENIENT. AS AGREED BETWEEN THEM, THEY MAY BE ACCOMPANIED BY OTHER OFFICE BEARERS AND/OR STAFF-OF THEIR RESPECTIVE ORGANIZATIONS.

### FIFTH

BOTH BUSINESS ORGANIZATIONS WILL CONDUCT THEIR AFFAIRS IN ACCORDANCE WITH THEIR OWN CONSTITUTION AND RULES.

### SIXTH

THE EXPENSES OF PREPARING FOR AND OPERATING JOINT MEETINGS WILL



BE THE RESPONSIBILITY OF THE HOST ORGANIZATIONS FROM REGISTRATION PEES, CONTRIBUTIONS AND / OR LEVIES; BUT IN ALL CASES DELEGATES TO JOINT MEETINGS WILL BE RESPONSIBLE FOR THEIR OWN TRAVEL AND ACCOMMODATION EXPENSES.

#### **SEVENTH**

BOTH PARTIES SHALL ESTABLISH A JOINT COMMITTEE CONSISTING OF ME-MBERS FROM MAJOR BUSINESS SECTORS ON EACH SIDE TO UNDERTAKE PRO-MOTING OF ECONOMIC COOPERATION BETWEEN THE TWO COUNTRIES.

## EIGHTH

BOTH PARTIES SHALL DO ALL THEY CAN TO ENSURE THAT THIS AGREEMENT OF COOPERATION WORKS TO THEIR MUTUAL BENEFTT; IT SHOULD BE JOINTLY REVISED FROM TIME TO TIME AS DEEMED APPROPRIATE.
