- 3.The term of this agreement shall begin on October 1, 2004, and end on September 30, 2007. TECRO and AIT/T shall have the option, upon mutual consent, of renewing this agreement on the same terms and conditions set forth herein for a further period to be determined.
- 4.Any back rents owing to prior occupation and use of these properties are hereby null and void.
- 5.This Agreement may be terminated upon the mutual written agreement of TECRO and AIT/T.
