

法規名稱：DECISION NO.19 - MODIFICATION PURSUANT TO THE TARIFF TREATMENT FOR 7 PRODUCT ITEMS INCLUDING MOTOR VEHICLE PARTS, PAPER SACKS AND BAGS, MOTORCYCLE AND ADHESIVES OF ANNEX 3.04 OF THE FREE TRADE AGREEMENT BETWEEN THE REPUBLIC OF CHINA (TAIWAN), THE REPUBLIC OF EL SALVADOR AND THE REPUBLIC OF HONDURAS

The Administrative Commission of the Free Trade Agreement between the Republic of China (Taiwan), the Republic of El Salvador and the Republic of Honduras ( “ the Agreement ” ), pursuant to its powers and according to what is established in Article 14.01 (3)(b)(i) of the Agreement,

DECIDES:

To modify Annex 3.04(1)(g) “ Tariff Reduction Schedule ” regarding the tariff treatment applied by the Republic of Honduras to 7 products including motor vehicle parts, paper sacks and bags, motorcycles and adhesives originating from the Republic of China (Taiwan), as follows:
