

**法規名稱：**DECISION NO 7 - MODIFICATION REGARDING THE TARIFF TREATMENT FOR 11 PRODUCT CATEGORIES—INCLUDING FRESH OR CHILLED SWINE, FROZEN BOVINE OFFAL, PREPARED OR PRESERVED MEAT OF BOVINE ANIMALS (HAMBURGER BEEF) , OTHER SUGAR CONFECTIONERY, RICE PAPER, EXTRACTS OF TEA OR MATE, OTHER FOOD PREPARATIONS, WADDING OF MAN-MADE FIBERS AND BLANKETS OF SYNTHETIC FIBERS—IN THE LIST OF PRODUCTS OF THE REPUBLIC OF CHINA (TAIWAN) IN ANNEX 1 OF THE AGREEMENT ON ECONOMIC COOPERATION BETWEEN THE REPUBLIC OF CHINA (TAIWAN) AND THE REPUBLIC OF PARAGUAY

The Joint Committee governing the Agreement on Economic Cooperation between the Republic of China (Taiwan) and the Republic of Paraguay ( “ the Agreement ” ), in accordance with its powers and pursuant to Articles 6 and 23 of the Agreement and Decision No. 1,

DECIDES:

1.To modify the List of Products of the Republic of China (Taiwan) in Annex 1 of the Agreement, adding the following 11 product categories — including fresh or chilled swine, frozen bovine offal, prepared or preserved meat of bovine animals (hamburger beef), other sugar confectionery, rice paper, extracts of tea or mate, other food preparations, wadding of man-made fibers and blankets of synthetic fibers — and reducing their customs tariffs for importation into the Republic of China (Taiwan).

2.To immediately eliminate tariffs for product categories with the following tariff lines:
