ARTICLE I-PURPOSE

This Appendix to Annex 2 to Memorandum of Agreement NAT-I-845 (the Agreement) sets forth the terms and conditions under which the American Institute in Taiwan (AIT), through its designated representative the Federal Aviation Administration (FAA), will provide civil aviation related training to the Taipei Economic and Cultural Representative Office (TECRO) in the United States, formerly the Coordination Council for North American Affairs (CNA). (CNA).

ARTICLE II-DESCRIPTION OF SERVICES

A.AIT, through its designated representative the FAA, will arrange for two specialists with backgrounds in aircraft certification to conduct for TECRO a two (2) week course on the Aircraft Certification Systems Evaluation Program (ACSEP) on or about February 1999.

B.Should additional services be required, the date, duration, and estimated cost of such services will be agreed to by the parties in a written amendment to this Appendix or in a separate appendix.

ARTICLE III-FINANCIAL PROVISIONS

A.The estimated cost for two specialists for the referenced period is twenty-three thousand, eight hundred forty six (\$23,846) U.S. dollars, which includes salary and benefits, transportation, per diem, AIT support and an administrative overhead charge.

B.TECRO will reimburse AIT for the actual costs incurred by AIT in providing the services under this Appendix and an administ-

rative overhead charge.

C.AIT bills will contain a reference to the Appendix Number NAT-I-845-2-4 and billing number NB9205TW8 (which are the numbers assigned to identify this Appendix and which will be referred to in all related correspondence), and will be supported with a summary of charges.
