I Note from the Embassy of the Republic of China to the Ministry of Foreign Affairs of Tuvalu

The Embassy of the Republic of China presents its compliments to the Ministry of Foreign Affairs of Tuvalu and has the honour to inform the latter that the Government of the Republic of China desires and proposes that the present Fisheries Licensing Agreement between the Government of Tuvalu and the Taiwan Deep-Sea Tuna Boat Owners and Exporters Association of the Republic of China be extended for another year with the terms, conditions and general contents of it remain unchanged but on a 49 boats US\$72,373.00 a year basis.

If this is acceptable to the Tuvaluan Government, then this Memorandum and the Memorandum in reply confirming such acceptance from the Ministry will constitute an Agreement between the two Governments which will enter into force on the date of March 4, 1985, on the extension of the "Agreement Between The Government of Tuvalu And The Taiwan Deep-Sea Tuna Boat Owners And Exporters Association Of The Republic Of China Concerning the Licensing Of Fishing Vessels Of the Republic Of China to Fish Within The Fishery Limits OF Tuvalu" for another year, that is to say, from March 5, 1985 to March 4, 1986.

The Embassy of the Republic of China avails itself of this opportunity to renew to the Ministry of Foreign Affairs of Tuvalu assurances of its highest consideration.

The Ministry of Foreign Affairs confirms that this Memorandum plus the Embassy's Memorandum under reference will constitute an Agreement between the two Governments on the aforementioned matter.
