- 2. To translate dates of birth, issue and expiry to Western style add 1911 to the first two digits, e.g., 1911+88=1999.
- Driver's licenses shall be renewed every 6 years starting from the original issuing date.
   Holders of driver's licenses shall apply to motor vehicle offices for renewal between 1 month

before and after the expiration date. From July 1, 2013, citizens and foreigners with Alien Permanent Resident Certificate are exempted from the renewal of the non-professional driver's licenses every 6 years.
