Examination fee		<p>The examination fee shall be calculated and collected at the following rates based on the duty-paid price:</p> <p>The examination rate for imported traditional Chinese medicinal materials is 1.5 ‰. If the examination fee is less than TWD200, it will be charged at TWD200 per case. If the amount exceeds TWD100,000, the exceeding amount will be charged by half.</p> <p>The examination rate for imported drugs is 2.5 ‰. If the examination fee is less than TWD500, it will be charged at TWD500 per case. If the amount exceeds TWD100,000, the exceeding amount will be charged by half. Active pharmaceutical ingredients are exempted from examination fee charges.</p> <p>The examination rate for imported medical equipment is 2.5 ‰. If the examination fee is less than TWD500, it will be charged at TWD500 per case. If the amount exceeds TWD100,000, the exceeding amount will be charged by half.</p>	
2. On-site examination fee		<p>According to the "Office Calendar of Government Administrative Offices" the service hours are from 8.30 am to 5.30pm during the work days of the week, and the charge will be TWD500 per site visit for each person. In case the services are required beyond the above-mentioned time period, additional fees shall be charged in accordance with the following provisions:</p> <p>TWD400 per person each time on work days from 6:00 am to 8:30 am or 5:30 pm to 10:00 pm.</p> <p>TWD1,000 per person each time on off days from 6:00 a.m. to 10:00 p.m.</p> <p>TWD2,000 per person each time for services required beyond the time specified in the first two provisions.</p> <p>In case an accommodation arrangement is required due to the actual status that the personnel who provide such services are unable to return on the same day, an extra fee shall be charged according to the Directions of the Domestic Travel Allowance Disbursement of the Executive Yuan.</p> <p>Active pharmaceutical ingredients are exempted from on-site inspection fee.</p>	
3. Notification Fee		A fee of TWD100 per copy for the re-issuance, renewal, additional copy of the drug import permit notification or registration content alteration.	
4. Inspection fee		The inspection fees shall be charged for the re-inspections of imported drugs, or the consequent inspections due to failure of sampling inspections.
