Remarks:

- I. This table shall only apply to the crime victims of the "act of sexual assault crimes" as defined in Article 3, Subparagraph 1, Item 2 of the Act.
- II. Considering the different circumstances or reasons of individual cases, if the defendant in a sexual assault case is subject to deferred prosecution or non-prosecution by the prosecutor in accordance with the Code of Criminal Procedure, but the relevant criminal facts are clear or with reference to the information obtained from the investigation of the judicial authority, the criminal facts deemed to exist, the Review Committee may still make a decision on compensation in accordance with this attachment and the range of payment standard stipulated in Article 28, Paragraph 2.
- III. In cases of sexual assault crimes where the Juvenile Justice Act is applicable, Review Committee shall make a decision on compensation based on the investigation results of the juvenile court (tribunal) and refer to this attachment and the range of payment standard stipulated in Article 28, Paragraph 2.
- IV. If a person is killed or seriously injured due to a criminal act of sexual assault, an application for compensation for crime victims may be filed directly in accordance with the provisions of Survivor Compensation or Serious injury Compensation.
